Dear Friends and Supporters,
As many of you will know from the explanation
on our website Save-A-Dog Scheme has had
the contract to operate the Stonnington
Regional Animal Pound since 1996.SADS
is therefore Stonnington's agent responsible
for the statuary requirements and components
of the pound. It has always been part of SADS
contract with Stonnington that SADS has the
right to operate any accommodation not
taken up by statuary needs as a "no kill"
animal shelter.

SADS operates out of the Stonnington animal pound and shelter as a registered animal welfare business/shelter.

In the last 12 months the City of Stonnington has undertaken the enlargement and improvement of the pound/shelter largely in response to a drastic increase in demand in the last few years for cat accommodation. I am very happy to be able to share some photos of the new improved facility in this newsletter and I must again state, so as to avoid any misunderstanding, that this facility is owned by Stonnington and the extension and refurbishment has been totally paid for by the residents and ratepayers of the City of Stonnington.

Save-A-Dog Scheme does own its own property, at Yarrambat, where it boards and

cares for its animals and the SADS facility works in conjunction with the council owned facility in Glen Iris. The SADS Yarrambat property is now in the arduous and challenging process of improvement and modification so it can also be registered as an animal shelter.

I am very proud that SADS continues to operate the Glen Iris pound/shelter and that the

provision of this state of the art facility reflects the community's commitment to animal welfare in the true sense ,for which SADS is exceeedingly grateful.

Save-A-Dog Scheme (SADS) was established in 1985 to offer a humane alternative to the killing of unwanted dogs, especially dogs of good temperament, that would otherwise be destroyed at pounds and shelters.

SADS is an incorporated, non-profit, community-based organisation controlled and operated by volunteers with the help of paid staff. It operates as a registered animal shelter and combines this with foster care in the community. Each dog is desexed, vaccinated, wormed, microchipped, vet-checked and temperament-assessed prior to adoption.

SADS has a no kill philosophy and believes that the dichotomy of a dog being "Mans Best Friend" on the one hand and unwanted article for destruction on the other is totally unacceptable. SADS is a "coal-face" organisation, which saves hundreds of dogs each year and which seeks, by example, to provide a better way of treating non-human animals.

Save-A-Dog Scheme relies on donations for its continuing existence and does not receive any government funding. Donations to Save-A-Dog Scheme are now tax deductible and help with the general care of the dogs and the maintenance of the organisation. The greatest expense is for veterinary treatment for the dogs, which includes the care of sick and injured dogs. These dogs are nursed back to health rather than being destroyed as they may be elsewhere.

Dogs & Cats For Adoption

All dogs and cats available from Save-A-Dog Scheme are de-sexed, vaccinated, wormed, micro chipped and vet checked.

Update – Planning Permit Application – Animal Shelter 292 Bannons Lane Yarrambat

We are continuing to board dogs and cats at our Yarrambat facility, which is proving helpful with our day-to-day operations. The planning permit application seeking planning permission for upgrade works however has stalled unfortunately, due to a number of reasons.

A number of objections to the planning permit have been lodged by neighbours at Yarrambat. Their main area of concern relates to noise.

Whilst this is not entirely surprising, it is disappointing considering the level of funds expended to construct the acoustic fence and the effort we put in to install the fence prior to boarding any dogs on the premises. It was anticipated that the fence would provide our neighbours with improved noise protection but it seems that the fence has not produced the desired result for all parties.

Because of this, Nillumbik Council have required further acoustic information in order to progress the application. Due to delays in obtaining this information, the application is currently on hold. We are optimistic that this information together with some resolution of noise issues can be provided to Council in the coming months.
